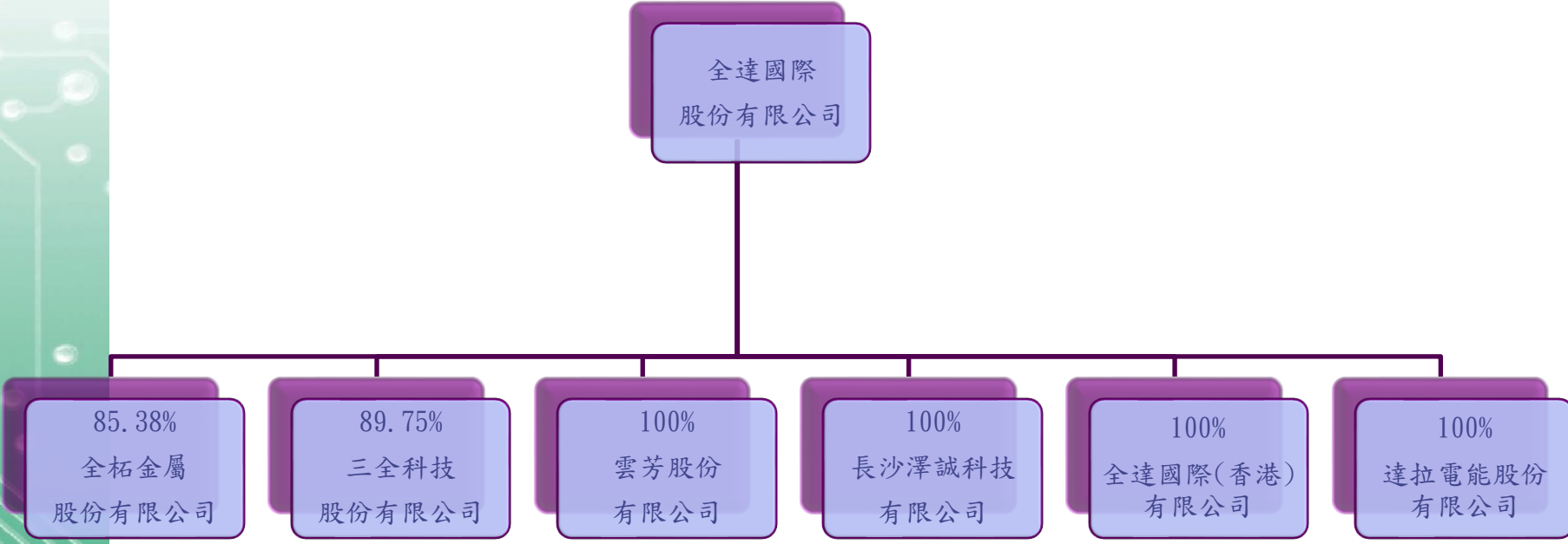

## Mobile Charging Robot

In June 2023, our subsidiary, Dala Electric, was established to venture into the electric vehicle charging market. We have already unveiled the E-HERO mobile charging robot and plan to commence operations in 2024. Our goal is to deploy 600 units within the next three years, with a primary focus on locations such as aging communities, hotels, shopping malls, and other areas where it is challenging to install fixed charging stations.

## R&D of metallization technology

In our subsidiary, Changsha Zecheng, we have established a high-tech laboratory specializing in the silicon nitride ceramic metallization process, which has relatively high technical requirements. We have successfully developed the related metallization technology and have been sending samples for testing. We anticipate that once we begin mass production and shipping in 2024, it will significantly contribute to our company's revenue and profitability.
